5. 10<sup>th</sup> (SSC) Marksheet
6. Proof of Payment – Applicable only for Candidates NOT Registered with ACPC.

#### **Option – I : CASH Payment**

#### **Option – II : Cheque or Demand Draft**

## Procedure for Admission

- Apply Online for the Vacant Seat Admission.
- Provisional Merit List will be prepared for Eligible Candidates as per norms of ACPC.
- Candidates will be communicated in a slot-wise manner for Counseling process.
- Admission will be offer on Vacant Seats as per the Provisional Merit list only during Counseling.
- Admission offered in counseling shall be confirmed immediately by payment of Full Fees for First Semester (as mentioned below) by Cheque or Demand Draft or Online Payment. Fees will not be accepted in CASH.
